ABOUT THE BUSINESS AREA MANAGER PROFILE

Key responsibilities of the Business Manager include development and communication of ENTSOG's future EU market design proposals, day-to-day management of the Market Area Team, managing/planning the various activities, leading/participating in ENTSOG work groups, representation of the Area activities at the ENTSOG Board and General Assembly, representation to external conferences, workshops and meetings as well as participation in processes led by the European Institutions.

The Business Area Manager will need to build, maintain and enhance an extensive network of both working and higher level contacts with ENTSOG member representatives as well as many key actors including the EC, ACER, European Parliament, NRAs, EU Member State representatives and energy related stakeholder organisations.

The Business Area Manager will manage a team of approximately 10 people supported by 2 Subject Managers and will be responsible for management and deliverables assigned by ENTSOG General Manager and Board.

CANDIDATES SHOULD PREFERABLY HAVE:

- ▲ Substantial (at least 5 years) gas industry experience, preferably from a gas Transmission System Operator
- ▲ Extensive knowledge on the European gas network and markets
- ▲ Excellent knowledge and know-how of European perspectives for the gas TSOs, the European gas infrastructure regulatory framework and the European Institutions
- ▲ Experience in leading development of strategy formulation to ensure appropriate evolution of arrangements to meet requirements of TSOs and other actors whilst addressing the EU's objectives
- ▲ Lead implementation and ongoing monitoring and support for capacity, balancing and tariff network codes and guidelines, including other matters as may be determined by regulation and ENTSOG
- ▲ Proven Managerial and inter-relational skills, in terms of managing the Market team members as well as in handling ENTSOG working groups and member representatives
- ▲ Well-developed skills in presentation on complex issues as well as in drafting reports/papers, addressing both expert and/or non-expert audience
- ▲ Fluent English language both in writing and speaking
