THE ROLE OF ENTSOG

The role of ENTSOG is to facilitate and enhance cooperation between national gas transmission system operators (TSOs) for gas across Europe to ensure the development of a pan-European transmission system in line with European Union energy goals. Its objectives are to promote the completion of the internal market for gas and stimulate cross-border trade, ensure the efficient management and coordinated operation of the European gas network and facilitate the European network's sound technical evolution.

ENTSOG is comprised of seconded staff from its members and therefore the organisation is constantly under dynamic change and ready to offer new opportunities. The ENTSOG staff currently consists of approximately 40 people of 17 different nationalities and representing 18 companies, which provides a unique and challenging international working environment.

ABOUT YOUR ROLE IN THE SYSTEM OPERATION TEAM

The ENTSOG System Operation Area is responsible for (1) facilitating implementation and preparing monitoring of key EU legislation, and (2) contributing to further developing the EU legislation in the areas of interoperability and transparency.

The EU energy market is in the process of a significant change to ensure that it is fit for purpose to meet the future challenges of decarbonisation. We participate in shaping the framework for the future European gas markets and networks and providing our expertise to help key policy makers in the development of EU gas regulation.

In your new role, you will contribute to our work on monitoring and functioning of the EU-wide gas network codes in the System Operation Area (interoperability) as well as the development of EU legislation, and feed into the debate on the technical aspects of the energy transition, with a focus on gas quality and hydrogen, security of supply, cybersecurity and digitalisation.



CANDIDATE REQUIREMENTS

The Candidates will be based in Brussels and should be **ready to start work** as soon as possible, at the latest **during Q4 2019. Fluent English**, both in speaking and in writing is essential. Appointees from ENTSOG Members will be seconded based on a contract between ENTSOG and the seconding TSO, usually for a period of **typically 2 – 3 years**.

Some of the key responsibilities of this Specialist role includes **leadership and support** for the development of the EU market rules and the technical aspects of the energy transition, **liaison with ENTSOG Members and stakeholders**, as well as participation in **processes led by the European Commission, ACER and other European authorities**. Candidates seconded from TSOs are preferred.

CANDIDATES SHOULD HAVE:

- ▲ a general knowledge of the European gas market framework and the European Institutions;
- ▲ a high-level familiarity of the EU-wide gas network code on interoperability and data exchange rules.
- ▲ an understanding of the potential future gas market and technical developments that may be needed to improve the current market and to meet future requirements;
- ▲ a good understanding, with some knowledge on the technical and regulatory aspects of gas quality, renewables gases, specially hydrogen, climate change debate, new uses of gas, and other relevant issues.

In addition, candidates for the interoperability specialist position should have:

- ▲ if possible, a good understanding of IT, cybersecurity, and digitalisation in the context of gas network operation,
- ▲ if possible, a good understanding of gas security of supply situation in Europe.

THE SUCCESSFUL CANDIDATE WILL ALSO BE ABLE TO DEMONSTRATE:

- ▲ an open minded and flexible approach, able to find compromises and results reflecting viewpoints of stakeholders;
- ▲ ability to develop and manage challenging project timelines, possess strong organisation skills and able to present complex concepts and ideas;
- ▲ skills of contributing to the success of a team by demonstrating initiative, persuasion, negotiation skills and a willingness to support others both within this and other parts of the ENTSOG organisation;
- ▲ strong work ethics and associated flexibility to cope with demanding timelines and work pressures;

- ▲ an international mind set, focusing on the strengths of diversity as well as a respectful communication and dialogue;
- ▲ independence in thought, discussion and execution;
- ▲ proven ability in developing change proposals;

In addition, the interoperability specialist candidate should be interested in leading and managing a small team of advisers.

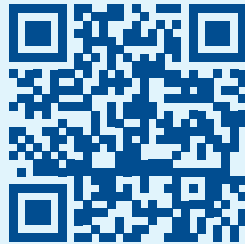
